I certify that I and/or the Minor are physically fit and have not been advised to refrain from any physical activity by any medical professional; I further certify that there are no health-related reasons or problems which preclude my and/or the Minor's participation in this activity.

I acknowledge and agree that this Accident Waiver and Release of Liability Form is intended to act as an inducement to Momo's Clubhouse LLC to allow entry to myself and the Minor in the participation of said activity; I further certify and agree that this Accident Waiver and Release of Liability Form is intended to be and shall be used by Momo's Clubhouse and that it will govern our actions and responsibilities at Momo's Clubhouse, including but not limited to following and adhering to all posted rules and regulations or inherent in participating in said activity.

In consideration of our participation in any activity at Momo's Clubhouse, I hereby take action for myself and the Minor, as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE THE FOLLOWING ENTITIES OR PERSONS: Momo's Clubhouse LLC and/or their directors, officers, employees, volunteers, representatives, and agents from any and all liability, including but not limited to, liability arising from negligence or fault of the entities or persons released, for my or our death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or the Minor.

(B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO TAKE ANY LEGAL ACTION AGAINST the entities or persons mentioned in paragraph (A) from any and all liabilities or claims made as a result of participation in this activity, whether caused by their negligence or otherwise.

I acknowledge for myself and the Minor that Momo's Clubhouse LLC and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on the premises.

I acknowledge for myself and the Minor that this activity may involve physical activity and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent for myself and the Minor to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

I understand while participating in this activity, I and/or the Minor may be photographed. I agree to allow my or the Minor's photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

Any person of legal age (18 years and older) executing this Accident Waiver and Release of Liability Form hereby acknowledges and agrees that the singular use of "I", "my", or "me" contained herein shall be construed in the plural to include any minor child or children, if any.

This Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL FOR ITS STATED PURPOSE AS AN INDUCEMENT TO MOMO'S CLUBHOUSE TO ALLOW MY/OUR ENTRY AND PARTICIPATION THEREIN.
